
Portfolio Strategy

THE BROOKMONT CORE DIVIDEND STRATEGY is a value strategy of 30-50 individual common stocks that seeks a competitive total return by investing in equity securities that provide a balance between current income and income growth with the potential for long-term capital gains, lower volatility, and downside risks.

Investment Process

The firm utilizes its bottom up process facilitated by quantitative screens of fundamental characteristics to narrow the selection universe. Once the selection universe is created, the team utilizes bottom up fudamental analysis to find companies to that superior operational cash flow and free cash flow growth metrics relative to their peers.


