
## **Portfolio Strategy**

THE BROOKMONT QUALITY GROWTH STRATEGY is a total return portfolio of 30-45 common stocks that invests in equity securities that provide a moderate level of current income, an above average capacity for income growth, and the potential for long term capital gains with lower downside risks. The strategy typically invests in eight economic sectors as defined by the S&P 500 Index.

#### **Investment Process**


The firm utilizes its bottom-up process, which is facilitated by quantitative screenings of a 3 year compounded annual growth rate above 10% in Revenue, Adjusted EPS, and Operating Cash Flow. Further fundamental analysis is performed incorporating Brookmont's macro investment themes to arrive at our portfolio on 30-45 positions


